Your membership includes accidental death and dismemberment insurance coverage. Unless otherwise stated by you, beneficiaries shall be this order: spouse, children, parents and siblings. To request a beneficiary designation different from above, receive a change form from your financial institution. Once completed, they will file it with your enrollment card. This is only a brief description of the coverage available under the policy. Many travel assistance information services are included as part of this plan. Also included are medical and emergency assistance services while traveling more than 100 miles from your home, including abroad. The policy contains reductions, limitations, exclusions, and termination provisions. Full details of coverage are contained in the policy. If there are any conflicts between this document and the policy, the policy shall govern. All coverage options may not be available in all states. You do not need a copy of the Description of Coverage Form to file a claim. If you need to file a claim, please call your financial institution or the Sisk Association at 800-899-7175 to obtain a claim form. You are a member of the Sisk Association when you enroll in the package through your financial institution.

TO RECEIVE A CELLULAR TELEPHONE PROTECTION GUIDE TO BENEFIT

Subject to the terms and conditions provided in the Guide to Benefit, Cellular Telephone Protection will reimburse the enrolled account holder (the "Accountholder", also referred to as "You" or "Your") for damage to or theft of eligible Cellular Wireless Telephones. The policy contains limitations, exclusions, and termination provisions. Full details of coverage are contained in the policy. If there are any conflicts between this document and the policy, the policy shall govern. Coverage options may not be available in all states. This coverage is not insured by the FDIC or any other government agency. Eligible Cellular Wireless Telephones are the primary line and up to the first four secondary, additional, or supplemental lines as listed on Your cellular provider's monthly billing statement for the billing cycle preceding the month in which the theft or damage occurred. You must charge your monthly Cellular Wireless Telephone bills to your eligible account. Protection begins on the first day of the calendar month following the payment of the Cellular Wireless Telephone bill using an eligible account. If the account holder fails to make a Cellular Wireless Telephone bill payment in a particular month, protection is suspended. Cellular Telephone Protection is subject to a fifty-dollar (\$50.00) co-payment per claim and a maximum of two (2) claims per twelve (12) month period. The maximum benefit limit is \$250.00 per claim and \$500.00 per twelve (12) month period. To file a claim, call the Benefit Administrator at (800) 899-7175 within sixty (60) days of damage or theft. Lease and pay as you go plans are excluded. Please note: If You do not give such notice within sixty (60) days after the damage or theft Your claim may be denied.
